
VANI is an apex body of voluntary organizations, which works as a catalyst between the voluntary sector and the government, private sector, bilateral and multi-laterals. VANI continuously attempts to create a common platform where Indian voluntary development organizations can collectively voice the issues that have been concerning and affecting the sector. VANI has been providing support to grass root organizations on regulatory issues like incorporation laws, taxation laws, other laws related to fund generation, accountability and governance. VANI also works as the voice of the sector to make government, private sector, media and general public to make them aware about the concerns, achievements and challenges to reduction of poverty and hunger, social inclusion along with sustainable development as well as of the sector. VANI provides advice, suggestions and files appeals on the above issues. VANI also organizes educational events like seminars, consultations, roundtables and capacity building workshops to not only share the information at various levels from grassroots to national, but also to generate information for its epistemological role for the voluntary development sector in India. VANI is committed to promote and strengthen accountability and transparency in the VDOs on governance management and financial transactions.

In the era when space for voluntary action is being redefined globally, India is no different. On one hand the regulatory environment is becoming more complicated and on the other traditional windows of partnerships is being replaced with new spaces. The strategies for resilience adopted by VDOs differ due to their location, size, strategies and themes. During the year, VANI kept its commitment of strengthening the sector at the centre while implementing all its interventions. The question of highlighting the narrative of the sector about its success, achievements and challenges along with communicating concerns with policy makers, government and donors has become very important. The VDOs at the grassroots face existential challenge due to inadequate support structure of technical, legal, human resource and thematic inputs. The weak infrastructure to facilitate the flow of information from national to local and local to national also emerged as major challenge. This year new forums have been created - forum of chief executives, leaders forum, women leaders, financial experts and chartered accountants, as platforms for dialogue, mutual sharing and learnings.

The year also saw, India emerging as the major player in development partnerships and discourses, which also included the reforming of global governance mechanism of multilateral platforms like World Bank, IMF, and UN Systems. The new platforms like BRICS, G20, IBSA, etc gained importance on development initiatives. To carry forward its commitment to strengthen the global footprints of Indian and Southern VDOs, VANI conducted studies, multi-stakeholder dialogues in collaboration with FIDC, RIS and MEA. With the objective to mutually learn and share experiences of Indian VDOs, VANI actively participated on various global and regional platforms of VDOs like CIVICUS, IFP, and ADA.

A paradox of Regulatory Environment

The regulatory framework for the VDOs suffers from multiple interpretations from diverse perspectives. Various rules and regulations are made in bits and pieces, which are sometime contradictory in nature. This year VANI made efforts to articulate the need for harmonization of the laws in line with the private sector as well as enhanced capacity of VDOs for compliance. Being a member of the committee formed by MoRD, Government of I ndia, to respond to Hon'ble Supreme Court of I ndia,

VANI put forward the need for professionalization and updating of regulatory framework which promotes accountability, transparency and legitimacy of the VDOs. Most of VANI 's recommendations were accepted by the government and Hon'ble Supreme Court. VANI is also member of the committee formed by NITI Aayog to recommend changes in the regulatory framework. After a series of consultations with VDOs from grass roots and national level and inputs from experts, the basic demand is to streamline and promote "Ease of Doing Development Work". The outdated registration laws have resulted in 3.5 million non-profit entities, which are not necessarily development actors. Similarly, Section 2(15) (of which law) needs redefinition to promote partnership between VDOs and flagship programs of the government. The gap is also felt between the provisions of CSR laws and I ncome Tax Act, to promote domestic fund mobilization. VANI strongly believes that in order to achieve SDGs effective partnership is needed between government, VDOs and private sector.

Strengthening the Sector from Within:

Promoting Accountability and Transparency in VDOs

As mentioned above in such a regulatory environment, it becomes necessary for the VDOs

to become accountable and transparent. From the study conducted by VANI, it can be estimated that out of the 3.5 million non-profit entities there are not more than 300,000 VDOs that are involved in development work. In such an environment, it becomes very difficult even for donors to identify and support good and genuine organizations. With the strong base of 561 members and with outreach to thousands, VANI started working on methods,

processes and instruments to highlight such genuine VDOs. The role of knowledge creator

for the sector was further strengthened by designing instruments for showcasing good and genuine organizations. Building on data collected through various educational events and its partnership with global project on reference standards, VANI rearticulated it's 'Code of Conduct". This Code of Conduct not only has variable indicators but also came out from extensive conversations and consultations. This is now a tool of "Self-Certification". The same tool is also shared with NITI Aayog.

Making Governance Effective:

Since its inception VANI has done substantial work on making Governance effective for the VDOs. Now with changing times and redefined relationships, the nature, composition and functions of Governing Boards are also changing. VANI conducted a study to this effect which highlighted that eminent people from private sector, government, and academics are joining the boards. There is a need for professional board functioning and management and orientation of

members on effective engagement in the board functioning.

VANI also conducted the analysis of gender representation and leadership among the boards and it was observed that very few women leaders are in the sector. Although, large number of women joins the sector at entry level, their number decreases at the higher level of the organisation. This concern was shared with various organizations and women leaders. This year VANI launched 'Women Leadership Forum', which is led by VANI's board. In addition, there are two other forums namely, 'Chief Financial Officers Forum' which includes Financial Experts/ Charted Accountants and 'CEO/Leaders Forum' which is a network of Leaders, CEOs and experts. These forums are used as a platform to discuss the issues faced by the sector's and recommended action for way forward for nation building and development through voluntary development organizations.

Resilience and Local Fund Raising

Due to changed funding scenario, the organizations face the challenge in raising resources without compromising their mission and vision. The foreign funding to India is depleting and new donors require different approach. The emergence of philanthropic foundations, private sector (CSR) and individual donors require re-strategizing of fund raising techniques. Interestingly, now both donor and recipients do not understand each other's language and terminologies. Based



on its studies and feedback from stakeholders, VANI worked towards strengthening the

organizations in coping up with this challenge. Various studies have shown that there is a gap between available resources and expectation from the field. This year VANI initiated the capacity building as well as epistemological intervention on this area.

Narrative of the sector:

┘

There is very less information in public domain about the challenges and achievements of the voluntary development sector. In last decade or so, we have made our language so complicated with jargons that people on the street don't understand the nature, functions, contributions and challenges of the voluntary development sector. Being a voice of the sector, VANI undertook number of initiatives to motivate grassroots organizations to document their success

stories and challenges. The emergence of social media should be seen as an opportunity to further this objective.

Global Solidarity

I ndia has not only been a development partner since a long time but played an important role in extending its help to other developing and least developed countries. Globally, I ndia is seen as one of the key stakeholders in development cooperation. VANI through its efforts has achieved recognition not only at national but at international level as well. Through various activities led by VANI and the views and opinions are expressed on diverse issues which are valued by the

stakeholders in the global arena. VANI is an active participant in various global forums and platforms. VANI started its efforts to voice the issues of Indian CSOs at global level and has gained a sense of solidarity with the global CSO programmes. This year VANI has been at various platforms, - C2O, Global Standards, CIVICUS, Civil BRICS, ADN, IFP, etc. to name a few.

The engagement of VANI in different forums contributed in building legitimacy of the sector for representation on matters related to CSOs working at grassroots to the national level of development in India. It participated in evidence based advocacy on common issues with voluntary sector by building a strong national and international research and advocacy capacity. VANI has an important contribution in shaping the position of Indian voluntary sector at global forums and also is an active board member of the FIDC anchored by RIS-the MEA think-tank.

Membership



Many VOs have extended their support towards VANI by being a member to take a collective action for the sector. The steady growth in membership is a proof that the work done by VANI is supported and that VANI is truly a membership-based organization. VANI has a total membership of 561 organizational members (as on 31st March, 2018). VANI has a reach of more than 10,000 organizations across India, working in



remotest and farthest areas of the country. VANI also reaches out to its non-members through state and regional meetings.

VANI invites not only members but non-members as well to the various meetings, consultations and workshops. Through these events information is shared on issues, concerns, new circulars and amendments in laws relevant to the sector. VANI not only utilizes such occasions and events to disseminate the information and capacity enhancement but also to gather inputs, observations and recommendations from all the participants, later to be compiled and shared with the external stakeholders like government, private sector, media and others.



Regional Hub

I ndia being a federal democratic country, it is very difficult for VANI to support VDOs in 29 states and 7 Union Territories. To strengthen the outreach of VANI to the voluntary organizations working at grassroots level in remotest and farthest areas of the country, outreach support through VANI's Regional Hubs as considered successful. The role of regional hub is to collect information about challenges that grassroots level organizations face and extend support in time of need. All the data and documents are regularly provided to the VANI Secretariat. There are three Regional Hubs that are managed by VANI namely- South, East and North-East. These Hubs are strategically located to provide intensive support to the organizations and disseminate information as well.

Redefining relationships:

With the Government

VANI believes that for the holistic growth and development of the country, a vibrant and constructive partnership between government and VDOs is a prerequisite. VANI has a functional relationship with various ministries and government departments at state and national level. VANI is considered as a knowledge hub and research centre on issues related to VDOs by the government. VANI's involvement ranges from organizing

pre-budget consultations to provide inputs and information on behalf of member VDOs and various committees. With the changing times, the opportunity and windows of interaction between government and VDOs have also changed. VANI worked tirelessly to strengthen this relationship for the benefit of the sector. During the year VANI organized various events for information exchange.

With the Media

Media plays an important part in shaping the opinions and image of any sector. It is a significant medium to highlight the issues of the voluntary sector. As a watchdog, media has provided timely information and promoted good governance, however, the impact of news on voluntary organizations over the last few years has had an adverse effect and the sector. The voluntary sector has been portrayed in negative light. VANI has made efforts from time to time and engaged with media

Strategic Meeting of VANI Staff






