  - later came to Chilkana Saharanpur along with another worker of the Nehru Yuva Kendra, Ms Manorama. After studying the area for nearly two years I concluded that an integrated approach was needed for the development of this area. To meet this requirement of Disha social organization was established.
  - In the initial stage of work, I made efforts to organize agriculture labor. Cooperation of people especially of women of sultanpur Chilkana area and Ghad area was unforgettable. I known for advocating the interest of women at the National and international level. As I linked to feminist ideology, I have made combat against Violence against women, imparting equal status to women in the society and to make free the women of all kinds of social and economic exploitation was the main agenda of the organization. I have given comprehensive programmes for economic freedom for the women.
